- 6) Names must be submitted for all team events i.e. Relays, without which entries will not be accepted.
- 7) Only properly completed Entry Forms, with the name of the School, Principals Name, Signature and Rubber Seal will be accepted.

Protest

: A protest must be lodged in writing, duly signed by official-in-charge, within 30 minutes of the end of the event together with protest fees of Rs. 1000/-, which will be forfeited if protest is rejected. The decision of the Jury of appeal shall be Final and Binding on all the participants.
